The Utah Division of Securities (Division), by and through Jeffrey Buckner, Assistant Attorney General, and pursuant to Rule 41(a)(2) of the Utah Rules of Civil Procedure, to the extent those rules may be looked to as persuasive in this proceeding, *see Utah Admin. Code R151-46b-5(3)*; hereby moves for dismissal of the emergency cease and desist order filed on October 3, 2003. Respondents served their response through attorney James Barber on November 5, 2003. Mr. Barber subsequently died and no one is currently representing Mr. Pantone in this proceeding. Mr. Pantone was declared incompetent in a companion criminal action.

Rule 41(a)(2)(ii) allows dismissal upon terms and conditions as the court deems proper. In this case, dismissal is proper because the Division is unable to file a stipulated motion since there is no attorney representing Mr. Pantone and he cannot stipulate since he is incompetent. In the alternative, the Division asks that counsel be appointed pursuant to Rule 74(c) to sign a stipulated motion of dismissal.
