The Utah Division of Securities (Division), by and through counsel, and pursuant to Rule 7 of the Utah Rules of Civil Procedure, to the extent applicable in agency proceedings before the Department, again requests a ruling on Respondents' motion to dismiss and the Division's motion for summary judgment, and the Division's post-hearing brief. In the alternative, the Division requests a trial setting.

In addition to the Sixth Circuit decision in Brown v. Earthboard Sports USA, Inc., 481 F.3d 901 (6th Cir. 2007) and other cases cited in the Division's supplemental authorities and brief filed in May 2007, rejecting Temple v. Gorman, two more California decisions have refused to follow Temple: Consolidated Management Group, LLC v. Dep't of Corporations, 162 Cal. App. 4th 598, 75 Cal. Rptr. 3d 795 (Cal. App. 1st 2008); and Apollo Capital Fund, LLC v. Roth Capital Partners, LLC, 158 Cal.App.4th 226, 70 Cal.Rptr.3d 199 (Cal App. 2d 2007).
