A hearing was held in this matter on Thursday, July 6 pursuant to an Order to Show Cause and Notice of Agency Action issued by the Division on June 6, 2006. At the hearing, the Division was represented by Jeff Buckner, Assistant Attorney General, and Jennifer Korb, of the Division of Securities. Dwight Williams appeared on his own behalf.

No appearance was made for Video Projects and no written response has been filed by Video Projects. Mr. Williams said Video Projects has been defunct for several years and said he was not appearing on behalf of the company. At the request of the Division, the Presiding Officer found Video Projects to be in default and said he would enter a default order if requested by the Division.

A consent order was entered previously involving Respondent Caldwell. Proceedings now are concluded for him. Accordingly, this matter requires further proceedings only for Respondent Williams.


Respondent Williams indicated an intent to file a motion to dismiss or quash these proceedings. A schedule was set for the filing of motions and responses.

IT IS HEREBY ORDERED:

1. Any motion by Respondent Williams to dismiss or quash these proceedings must be submitted by August 7. If he decides against filing a motion to dismiss, his written response and answer must be filed by that date.
2. The Division's response to any dismissal or quash motion by Respondent Williams is due by August 21.
3. Any reply by Respondent Williams must be filed by August 31.
4. A hearing will be held on September 7, 2006 at 9:00 to consider the motion and to set further scheduling for this matter.

The original copies of all motions and responses in this case must be filed with the Division. Copies are to be sent to the opposing party or its counsel, if represented.
