A hearing was held in this matter on Friday, August 04, 2006 pursuant to an Order to Show Cause and Notice of Agency Action issued by the Division on June 29, 2006. At the hearing, the Division was represented by Jeff Buckner, Assistant Attorney General, and Jennifer Korb, of the Division of Securities. Elizabeth Ward (previously Elizabeth Mowen) attended the hearing and was represented by James L. Driessen. Jeffery Mowen also attended the hearing. He was accompanied by Michael T. Holje, who indicated he is in the process of being retained by Mr. Mowen.

The presiding officer noted that a Response has been filed on behalf of Elizabeth Ward. At the hearing, a schedule was set for further proceedings in this matter.

IT IS HEREBY ORDERED:

1. Mr. Mowen will have until August 18 to file his response.
2. The parties will exchange documents related to the Division's proceeding by September 4, 2006.
3. Any motions must be submitted by October 4.

4. If there are any motions submitted, the responses will be due by October 18 and the replies, if any, by November 1.
5. Expert witness reports, if any, will be submitted by December 15.
6. Each side will file a list of witnesses and exhibits by January 15, 2007.
7. The case will be retained by the Presiding Officer for at least the near term.

The parties anticipate the hearing will take three days. It is expected that the hearing will take place in early February 2007.

The original copies of all filings in this case must be filed with the Division. Copies are to be sent to counsel for the opposing party.
