The Respondent, J.D. PULVER, hereby states:

This matter has been resolved of almost seven years. The damage inflicted on me has been done with no cause or proof of the matter. My addresses and phone numbers have been the same for almost ten years now. I did, however, move from the previous address you tried to reach me at, but the Division of Securities has also had my current address for the last seven years. The Default should have been set-aside when I requested it. I filed the proper Answer and Motions as required and had two telephone hearing of which I recorded with the dates.

This is a formal request and Motion to Dismiss the old allegations that were never proven to be valid because they are not and the Statute of Limitations has been reached. I reassert all of the reasons I stated in my previous Motion to Dismiss that was filed in 2007. I further request that the false statements posted by the Division of Securities that are accessible by the public through Google and other Internet search engines be removed as those statements are Libelous and False.

I will not be available for the prehearing scheduled for Friday, August 10th as I will be out of town with limited cellular service. (This trip has been planned for three months and

Respondent thought this matter with the Division was resolved years ago.) The Division may schedule a new prehearing conference after that day and time.

In regards to Division's Motion to Strike, Respondent has no record of any documents sent by the Division with that title and hereby reaffirms Respondent's Motion to Dismiss and Motion to Set Aside the Default Judgment.

On February 23, 2007, Mr. J.D. Pulver, forwarded via facsimile and email additional documents relating to the Flavor Brands, Inc. matter. The Flavor Brands matter involves a default judgment which was entered into against Mr. J.D. Pulver by the Division of Securities of the Department of Commerce of the State of Utah.

The materials forwarded by Mr. Pulver included the Articles of Incorporation of Turkey Jerky, Inc. dated March 2, 1984, accompanied by various amendments thereto. Included in these amendments is the name change Turkey Jerky, Inc., to Flavor Brands, Inc., effective September 30, 1991 (hereinafter "Original Flavor Brands").

In addition, Mr. Pulver included copies of annual reports presented to the State of Utah on behalf of original Flavor Brands, Inc. It should be noted that Mr. Pulver is not named or otherwise acknowledged to have been an officer, director, shareholder, or have any affiliation with Original Flavor Brands, Inc.

In addition, included are the Articles of Incorporation of Flavor Brands, Inc. filed May 24, 2005 ("New Flavor Brands"). The Articles of Incorporation were filed and executed by Ms. Denise Sullivan, the Sole Incorporator, who made representations within these articles that it was the intention of New Flavor Brands to accept the shares of Original Flavor Brands in exchange for shares of New Flavor Brands. Ms. Sullivan neither illuminates nor mentions the fact that Original Flavor Brands was dissolved previously and could not be resurrected.

In addition, included in the materials are Registration Information Change Forms noting the officers and directors of New Flavor Brands. Effective June 23, 2005, the officers were Denise S. Sullivan, President, Charles Langrill, Secretary and Treasurer and the directors included Messrs. Charles Langrill, Joseph Acaro (though misspelled in the filing as Akerp) and Denise Sullivan. As of March 23, 2006, a Registration Information Change Form was filed removing Mr. Acaro as Vice President and Secretary/Treasurer; and adding Mr. Tim Haskin as Vice President, and as Secretary/Treasurer. This form was submitted by Tim Haskin. Also note, that on March 23, 2006, an additional Registration Information Change Form was filed by

Denise Sullivan, removing herself as President and in lieu thereof, naming J.D. Pulver as President. This form was signed by Ms. Sullivan. Mr. Pulver has stated he did not accept this appointment.

Also note, that on some date in 2006, which cannot be distinguished from facsimile of the form, Joseph Acaro submitted a Registration Information Change Form representing himself as President of New Flavor Brands.

Lastly, New Flavor Brands filed a Voluntary Articles of Dissolution with the State of Utah on September 7, 2006 - this Dissolution notice was also signed by Mr. Joseph Acaro as President.
