Pursuant to R151-46b-9(9)(c)(vi) of the Utah Administrative Code, the Division of Securities of the Department of Commerce of the State of Utah hereby requests a pre-hearing conference to schedule a hearing in this matter. The Division commenced agency action against NevWest Corporation, Brisam Corporation and Brian Arthur Kitts (Respondents) on July 16, 2007.<sup>1</sup>

<sup>1</sup>The Division also initiated an emergency cease and desist order in a related matter against Jared Bird, SD 07-0057, on September 4, 2007.

Respondents filed an answer through counsel on September 12, 2007. The Division tried to explore settlement shortly after the order to show cause was filed, but received no response.

On October 23, 2009, Brian Arthur Kitts entered no contest plea to securities fraud, a second degree felony, and two counts of theft, a third degree felony in a related criminal case in the Third Judicial District Court, Case Number 071905099. Sentencing is set for December 18, 2009.

On October 27, 2009, the Division again inquired into Respondents' interest in settling the matter, but their response was non responsive: the administrative hearing should not proceed until after sentencing.


