BY THE PRESIDING OFFICER:

The notice of agency action and order to show cause in this matter were sent by the Division of Securities (Division) to the above-named Respondents on July 17, 2007. On September 10, 2007, Respondents filed an answer to the allegations outlined in the order to show cause. The parties executed a stipulated settlement agreement on December 19, 2011.

Paragraph 112 of the stipulated agreement states, "Respondents further acknowledge that if the Securities Commission does not accept the terms of the Order, it shall be deemed null and void and without any force or effect whatsoever." The stipulation was presented to the Utah Securities Commission (Commission) on January 26, 2012, but the Commission rejected it.

In these circumstances, the presiding officer finds that it is necessary to schedule further proceedings in this matter, as follows:

1. An initial hearing will be conducted on April 3, 2013 at the office of the Utah Division of Securities, located in the Heber Wells Building, 160 East 300 South, 2nd Floor, Salt Lake City, Utah, at 9:00 A.M. At the initial hearing, the presiding officer will establish dates and deadlines for making prehearing disclosures, completing discovery, and filing any prehearing motions.
2. If Respondents fail to attend the initial hearing, the presiding officer will, without further notice, hold them in default and assess a sanction and penalty consistent with the allegations contained in the Division's order to show cause.
3. Unless this matter is settled through a stipulated agreement, resolved through an order issued on a prehearing motion, or continued for good cause, a hearing shall take place before the Utah Securities Commission with anticipated hearing date of July 25, 2013.


