


**BY THE DIVISION OF SECURITIES:**

This adjudicative proceeding was initiated pursuant to the issuance of a February 4, 2008 notice of agency action. Sparing detail, a May 24, 2010 notice was issued, whereby an August 26, 2010 hearing was scheduled to be conducted before the Securities Commission.


Based on the foregoing, the Court now enters the following
