The Utah Division of Securities and Respondents Northern Developments Ltd. ("Northern") and Noah Sifuentes ("Sifuentes"), by and through their respective undersigned counsel, hereby stipulate to and request to entry of an order staying this matter pending the final resolution of the criminal charges currently pending against Sifuentes in the Fourth District Court in Provo, Case No. 081402106 (see copy of docket attached hereto) (the "criminal case"). Because the criminal case alleges the same underlying facts as are alleged in this matter, and because proceeding in this matter would substantially burden Sifuentes' rights under the Fifth Amendment to the

United States Constitution, the parties agree that this matter should be stayed until the criminal matter is fully resolved.

Sifuentes agrees that he shall give notice to the Division within ten (10) business days of the final resolution of the criminal case. In addition, he shall within that same time period give notice of any imposition of sentence, even if an appeal therefrom is filed.

WHEREFORE, Based upon the foregoing, the parties request that this matter be stayed pending the final resolution of the criminal case.

This stipulated motion is accompanied by a proposed order.
