**BY THE PRESIDING OFFICER:**

On February 23, 2012, Synergy Funding, LLC and Joshua Paul Chapman (Respondents), by and through their counsel of record Rebecca H. Skordas, filed a motion to stay the administrative proceedings in this matter. Respondent urges the stay in order to allow for an ongoing criminal case filed against Respondent Chapman to be concluded. Respondent Chapman was charged on August 28, 2008 in case number 081906646 (Third District Court, Salt Lake County, Utah) with two counts of second-degree felony securities fraud. As of the date of this order, the criminal case is on appeal.

It appears that the criminal charges arise from the same allegations set forth in the order to show cause issued April 11, 2008 in this administrative matter. Further, it appears that, as

Respondent argues, significant “judicial, administrative, and state resources would be saved by allowing the criminal case to conclude before proceeding” with the administrative action. Finally, the Utah Division of Securities has not opposed the motion for stay. In these circumstances, the presiding officer finds that granting the motion for stay is warranted.


**ORDER**


