**BY THE PRESIDING OFFICER:**

The notice of agency action and order to show cause in this matter were sent by the Division of Securities (Division) to Dennis John Rowley (Respondent) on July 26, 2012. As of the date of this order, Respondent has not yet filed his answer. A prehearing conference was held on September 5, 2012. During the conference, Respondent expressed his desire to consult with counsel prior to answering the allegations contained in the order to show cause, and the Division made no objection.


The presiding officer now enters the following scheduling order:

1. Respondent shall file his answer no later than October 5, 2012.
2. The parties shall exchange initial disclosures pursuant to Utah Administrative Code § R151-4-503 no later than October 5, 2012.

3. The parties shall complete discovery by October 26, 2012.
4. Any motion for summary judgment, dismissal, or other dispositive motion shall be filed no later than November 2, 2012. If any such motion is filed, the other party shall have until November 12, 2012 to respond, and the moving party shall have until November 19, 2012 to reply. If oral argument is required or requested on a motion, the presiding officer will issue a supplemental scheduling order setting a date and time.
5. Pursuant to Utah Administrative Code § R151-4-504(2), the parties shall disclose to one another all evidence that may be presented at hearing by November 21, 2012.
6. Unless this matter is settled through a stipulated agreement, a hearing shall take place before the Utah Securities Commission on November 29, 2012.
