BY THE PRESIDING OFFICER:

On October 29, 2012, the Utah Securities Commission entered a default order against the above-named Respondents due to their failure to file a response in answer to allegations set forth by the Utah Division of Securities (Division) in an order to show cause filed June 6, 2008.

On December 18, 2012, Respondents sent the presiding officer a letter in response to the default order. The presiding officer agreed to accept and treat the letter as a motion to set aside the default. Thereafter, representatives of the Division exchanged correspondence with Respondent White regarding evidence he claims to have and would be willing to present if the default were set aside and the matter taken to hearing.

On March 6, 2013, the Division filed an opposition to Respondents' motion to set aside the default.

Respondents are hereby notified that they have the right to reply in writing to the Division's March 6, 2013 opposition to their motion to set aside the default. The presiding officer now establishes a deadline of March 29, 2013 for Respondents' reply. In order to file a timely reply, Respondents shall take care to post their filing in a manner so as to account for any possible mail delays and ensure that the reply is received by the presiding officer and the Division on or before March 29, 2013.
