SCHEDULING ORDER

BY THE PRESIDING OFFICER:

The notice of agency action and order to show cause in this matter were sent by the Division of Securities (Division) to the Rayda Roundy (Respondent) on August 5, 2008. On September 23, 2008, Respondent filed an answer. Thereafter, the parties conducted negotiations regarding a stipulated settlement agreement, but have been unable to date to come to a resolution. In these circumstances, the presiding officer finds it appropriate to set this matter for hearing, as follows:

1. An initial hearing will be conducted on March 6, 2013 at the office of the Utah Division of Securities, located in the Heber Wells Building, 160 East 300 South, 2nd Floor, Salt Lake City, Utah, at 9:00 A.M. At the initial hearing, the presiding officer will establish dates and deadlines for making prehearing disclosures, completing discovery, and filing any prehearing motions.

2. Respondent may arrange to participate in the initial hearing by telephone by contacting Mr. Scott Davis, assistant attorney general, at 801-530-0358 prior to hearing.
3. If Respondent fails to attend the hearing or participate by telephone, the presiding officer will, without further notice, hold her in default and assess a sanction and penalty consistent with the allegations contained in the Division's order to show cause.
4. Unless this matter is settled through a stipulated agreement, resolved through an order issued on a prehearing motion, or continued for good cause, a hearing shall take place before the Utah Securities Commission with anticipated hearing date of May 23, 2013.


