BY THE PRESIDING OFFICER:

On or about September 4, 2008, the Division of Securities (Division) stipulated with Respondent Green to stay the administrative proceedings in case SD-08-0084 pending resolution of a related criminal case. On or about September 22, 2008 the Division stipulated with Respondent Cobb to stay the administrative proceedings in case SD-08-0082 pending resolution of a related criminal case. Although no stipulation was ever executed between the Division and Respondent Nielson, it appears that the proceedings in case SD-08-0083 were similarly placed on hold pending resolution of a related criminal case.

On May 8, 2013, the Division filed a motion to lift the stays in these cases, arguing that the criminal cases have been resolved. Pursuant to Utah Administrative Code § R151-4-303(2)(b), Respondents may respond to this motion. To that end, the presiding officer now enters the following scheduling order:

1. Respondents shall file any response to the Division's motion by May 20, 2013. *See* Utah Administrative Code § R151-4-303(2).
2. If a response is filed, the Division shall file any reply within five business days of the date on which the response is filed. *See* Utah Administrative Code § R151-4-107(2).
