

The State of Utah, Department of Commerce, Securities Division (“Division”), respectfully requests this tribunal to lift and terminate the stay entered on September 18, 2008, regarding Brett Jason Cobb (“Cobb”), and lift and terminate the stay entered on November 12, 2008, regarding Bradley Garth Green (“Green”). The basis for this request is that Cobb and Green agreed to a stay of these proceedings until such time as their respective criminal proceedings could be completed. On July 30, 2009, Cobb entered into a plea agreement, thereby pleading guilty to four counts of third degree securities fraud in the Third District Court (case no. 081904012). Similarly, on October 2, 2009, Green entered into a plea agreement, pleading guilty

to two Class A Misdemeanors for attempted securities fraud in the Third District Court (case no. 081904013). As a result, a stay of proceedings is no longer necessary in this action.

The Division also respectfully requests that this tribunal set a hearing as soon as it can be properly calendared to schedule further proceedings regarding all respondents in this administrative action.
