

The State of Utah, Department of Commerce, Securities Division (“Division”), respectfully requests that this tribunal set a hearing date, as soon as it can be properly calendared, to schedule further proceedings regarding the Respondents in this administrative action. The basis for this request is that an Order to Show Cause was filed against the Respondents on December 30, 2008. Through the accompanying Notice of Agency Action, an initial hearing was scheduled for February 4, 2009. On February 23, 2009, Respondents filed a motion to dismiss for lack of jurisdiction. On March 4, 2009, the Division filed its opposition to the motion to dismiss. Respondents never filed a response on that motion, and no order was ever issued; however, a parallel criminal proceeding commenced against Respondent Tippetts in the Fourth District Court

of Utah (case no. 091400935) on March 24, 2009. That action concluded September 22, 2009 with a plea in abeyance as to one count of securities fraud and one count of theft. Because the criminal action is no longer pending, the Division requests that this tribunal resume the administrative action as soon as practicable.


