The State of Utah, Department of Commerce, Securities Division (Division), respectfully requests this tribunal to lift and terminate the stay entered on November 10, 2010, regarding Arpeggio Investments, LLC, Stanley Duane Parrish, and Tyson D. Williams (Respondents), and to set a hearing to schedule this matter for further proceedings. The basis for this request is that the Respondents moved to stay these proceedings on November 1, 2010, because of a possible criminal referral, and because the Respondents wanted to pursue settlement negotiations with the Division (see Motion for Stay, dated November 1, 2010).

To the Division's knowledge, no criminal proceedings were commenced against Respondent Parrish. A criminal action was filed against Respondent Williams, but it was dismissed on February 13, 2012. No settlement negotiations have transpired between the parties since the stay was entered.

The Securities Division requests that a hearing be scheduled as soon as it can be properly calendared to schedule further proceedings in this administrative proceeding.
