SCHEDULING ORDER


The notice of agency action and order to show cause in this matter were sent by the Division of Securities (Division) to the above-named Respondents on September 30, 2010. On November 2, 2010, the administrative case was stayed due to a possible criminal referral. Since that date, no criminal charges have been filed. Therefore, on February 13, 2013, the stay was lifted. As of the date of this order, Respondents have not yet filed their answer to the order to show cause. A prehearing conference was held on March 18, 2013. During the prehearing conference, the Division agreed to accept an answer filed by March 19, 2013 as timely.

The presiding officer now enters the following scheduling order:

1. The parties shall comply with the initial disclosure requirement of Utah Administrative Code § R151-4-503 by April 1, 2013.
2. The parties shall complete discovery by June 12, 2013.
3. Any motion for summary judgment, judgment on the pleadings, or other dispositive motion shall be filed no later than July 12, 2013. If any such motion is filed, the other party shall have ten calendar days from the date of filing to respond, and the moving party shall have five business days from the date of response to reply. *See* Utah Administrative Code §§ R151-4-303(2) and R151-4-107(2). If oral argument is required or requested on a dispositive motion, the presiding officer will issue a supplemental scheduling order setting a date and time.
4. Should either party determine to use an expert witness, the party shall disclose the expert's name, contact information, and written report no later than July 12, 2013.
5. Pursuant to Utah Administrative Code § R151-4-504(2), the parties shall exchange final disclosures by August 12, 2013.
6. Unless this matter is settled through a stipulated agreement, resolved through an order issued on a prehearing motion, continued for good cause, or consolidated with a related case filed subsequent to the date of this order, a hearing shall take place before the Utah Securities Commission on September 26, 2013.
