On May 25, 2011, the Division issued an Order to Show Cause against Respondent. The Notice of Agency Action accompanying the Order to Show Cause set a hearing for July 6, 2011.


At the hearing on July 6, 2011 the Division was represented by Jeff Buckner from the Office of the Attorney General, Thomas Brady from the Division, and Douglas Wawrzynski from the Division. Respondent Louis Dean Parrish appeared on his own behalf. A schedule was set for further proceedings in this case.

IT IS HEREBY ORDERED:

1. Respondent shall file an answer by August 8, 2011.
2. The parties shall exchange evidence by September 8, 2011.
3. Any dispositive motions, such as motions to dismiss or for summary judgment, shall be filed by November 7, 2011. If such motions are filed, the other party shall submit responses by November 21, 2011 and the moving party shall have two (2) weeks after the filing of a response to reply. If oral argument on such motions is requested, a hearing shall be calendared and noticed.

4. Parties shall provide witness and exhibit lists to opposing parties and the Presiding Officer by November 30, 2011. Each side shall also identify any expert witnesses it intends to use and provide the other side with a copy of the expert's report by November 30, 2011.
5. An evidentiary hearing on the matter shall be held in December 2011. A specific date will be set and noticed at a later date.


