
On September 21, 2011, the Division issued an Order to Show Cause against Respondents, an Amended Order to Show Cause was issued by the Division on May 9, 2012. The Notice of Agency Action accompanying the Amended Order to Show Cause set a hearing for July 11, 2012.

At the hearing on July 11, 2012, the Division was represented by D. Scott Davis, Assistant Attorney General, Thomas Brady, Director of Enforcement and Ann Skaggs, Securities Analyst. Colby J. Sanders appeared telephonically on his own behalf. Counsel for the remaining Respondents, Adam D. Ford, was ill and unable to appear. The initial hearing with respect to all other Respondents represented by Mr. Ford will be rescheduled and noticed for a later date. A schedule was set for further proceedings in this case with respect to Colby J. Sanders.

IT IS HEREBY ORDERED:

1. Parties shall file initial disclosures by July 25, 2012.
2. The parties shall exchange evidence by August 10, 2012.
3. Any dispositive motions, such as motions to dismiss or for summary judgment, shall be filed by September 28, 2012. If such motions are filed, the other party shall submit responses by October 8, 2012 and the moving party shall have five (5) days after the filing of a response to reply. If oral argument on such motions is requested, a hearing shall be calendared and noticed.
4. Parties shall complete discovery by September 28, 2012
5. Parties shall provide witness and exhibit lists to opposing parties and the Presiding Officer by October 15, 2012. Each side shall also identify any expert witnesses it intends to use and provide the other side with a copy of the expert's report by September 10, 2012.
6. An evidentiary hearing on the matter shall be held on November 29, 2012 at 9:00 a.m.
