On February 17, 2012, the Division issued an Order to Show Cause against Respondents. The Notice of Agency Action accompanying the Order to Show Cause set a hearing for April 4, 2012.


At the hearing on April 4, 2012, the Division was represented by D. Scott Davis from the Office of the Attorney General and Thomas Brady from the Division. Justin R. Elswick, counsel for Respondents, appeared telephonically. A schedule was set for further proceedings in this case.

**IT IS HEREBY ORDERED:**

1. The parties shall exchange evidence by May 18, 2012.
2. Any dispositive motions, such as motions to dismiss or for summary judgment, shall be filed by June 15, 2012. If such motions are filed, the other party shall submit responses by June 29, 2012 and the moving party shall have two (2) weeks after the filing of a response to reply. If oral argument on such motions is requested, a hearing shall be calendared and noticed.
3. Parties shall complete discovery and provide witness and exhibit lists to opposing parties and the Presiding Officer by July 13, 2012. Each side shall also identify any expert witnesses it intends to use and provide the other side with a copy of the expert's report by July 13, 2012.

4. An evidentiary hearing on the matter shall be held on July 18, 2012. A specific date will be set and noticed at a later date.


