BY THE PRESIDING OFFICER:

The notice of agency action and order to show cause in this matter were sent by the Division of Securities (Division) to the above-named Respondents on November 5, 2012. On December 5, 2012, Respondent Provident Trust Group filed a motion to dismiss. The parties have stipulated to deadlines for response and reply as to the motion to dismiss, as further outlined below. On December 6, 2012, all Respondents timely filed an answer to the order to show cause. A prehearing conference was held on December 19, 2012. Based on the

representations of the parties, it appears that meaningful discussions and negotiations have already taken place regarding possible settlement of the case. In addition, the parties have already exchanged information and documents such that they have complied with the initial disclosure requirement of Utah Administrative Code § R151-4-503.

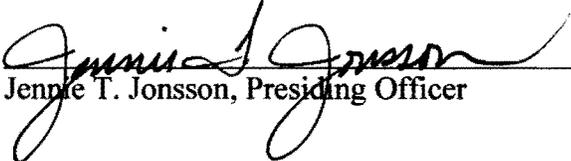
The presiding officer now enters the following scheduling order:

1. The parties have agreed that the Division shall respond to Respondent Provident Trust Group's motion to dismiss by January 7, 2013.
2. Pursuant to Utah Administrative Code § R151-4-303(2)(c), Respondent Provident Trust Group's reply regarding its motion to dismiss is due by January 14, 2013. The parties may agree to extend this deadline as necessary.
3. If oral argument is necessary on Respondent Provident Trust Group's motion to dismiss, the presiding officer will issue a supplemental scheduling order setting a date and time.
4. The parties shall complete discovery by April 5, 2013.
5. Any motion for summary judgment, judgment on the pleadings, or other dispositive motion shall be filed no later than April 23, 2013. If any such motion is filed, the other party shall have ten calendar days from the date of filing to respond, and the moving party shall have five business days from the date of response to reply. *See* Utah Administrative Code §§ R151-4-303(2) and R151-4-107(2). If oral argument is required or requested on a dispositive motion, the presiding officer will issue a supplemental scheduling order setting a date and time.
6. Pursuant to Utah Administrative Code § R151-4-504(2), the parties shall exchange final disclosures by April 23, 2013.

7. Should either party determine to use an expert witness, the party shall disclose the expert's name, contact information, and written report no later than April 23, 2013.
8. Unless this matter is settled through a stipulated agreement, resolved through an order issued on a prehearing motion, or continued for good cause, a hearing shall take place before the Utah Securities Commission on May 23, 2013.
