**BY THE PRESIDING OFFICER:**

The notice of agency action and order to show cause in this matter were sent by the Division of Securities (Division) to the above-named Respondents on December 31, 2012. A prehearing conference was held on February 6, 2013.

The presiding officer now enters the following scheduling order:

1. If Respondent wishes to file an answer or hearing brief in response to the Division's order to show cause, he shall do so by February 28, 2013.
2. The parties shall comply with the initial disclosure requirement of Utah

Administrative Code § R151-4-503



3. The parties shall complete discovery by March 29, 2013.
4. Any motion for summary judgment, judgment on the pleadings, or other dispositive motion shall be filed no later than April 12, 2013. If any such motion is filed, the other party shall have ten calendar days from the date of filing to respond, and the moving party shall have five business days from the date of response to reply. *See* Utah Administrative Code §§ R151-4-303(2) <http://www.rules.utah.gov/publicat/code/r151/r151-04.htm#T22>) and R151-4-107(2) <http://www.rules.utah.gov/publicat/code/r151/r151-04.htm#T7>). If oral argument is required or requested on a dispositive motion, the presiding officer will issue a supplemental scheduling order setting a date and time.
5. Pursuant to Utah Administrative Code § R151-4-504(2) <http://www.rules.utah.gov/publicat/code/r151/r151-04.htm#T31>), the parties shall exchange final disclosures by April 12, 2013.
6. Should either party determine to use an expert witness, the party shall disclose the expert's name, contact information, and written report no later than April 12, 2013.
7. Unless this matter is settled through a stipulated agreement, resolved through an order issued on a prehearing motion, or continued for good cause, a hearing shall take place before the Utah Securities Commission on May 23, 2013.

This order shall be effective on the signature date below.
