BY THE PRESIDING OFFICER:

An initial hearing was held in this matter on February 6, 2013 for the purpose of establishing a hearing date and setting deadlines for all prehearing disclosure and discovery. During that meeting, the parties indicated that they anticipated resolving this matter through stipulation. Accordingly, no firm deadline was established for Respondents to file an answer to the Division's notice of agency action and order to show cause.

On April 9, 2013, the Division filed a motion requesting a firm deadline by which Respondents shall be required to answer the allegations set forth in the order to show cause, none having been received to date.

Given the foregoing, the presiding officer now enters the following scheduling order:

1. If Respondents wish to file a response to the Division's motion for answer deadline, they may do so on or before April 18, 2012. Respondents bear the full responsibility to mail or otherwise deliver their response in a timely manner, and such that it is received by the Division on or before April 18, 2013.
2. The presiding officer will issue an order on the Division's motion for answer deadline on April 19, 2013, regardless of whether Respondents have filed a response.
3. Failure of Respondents to comply with any answer deadline established in the order issued April 19, 2013 shall constitute grounds for entry of a default order against him.

In addition, the hearing currently scheduled for May 23, 2013 is hereby continued to May 30, 2013 so as to accommodate the schedule of the Utah Securities Commission.
