**BY THE PRESIDING OFFICER:**

On January 17, 2013, the parties to this matter stipulated to stay the administrative proceedings until May 1, 2013 due to the possibility that criminal charges would be filed against Respondent. As of the date of this order, no criminal charges have been filed; however, it appears that the prosecutor has not yet made a final determination whether to take the case forward. Therefore, on April 26, 2013, Respondent filed a motion to extend the stay pending resolution of any criminal proceedings. The Division does not oppose Respondent's motion.

In these circumstances, the presiding officer finds good cause to extend the stay in the administrative case, contingent on a criminal action being filed within a reasonable period of time.


**ORDER**

The administrative proceedings in Division case number SD-12-0078 are stayed. Should criminal charges relating to the allegations set forth in the Division's administrative order to show cause be filed against Respondent during the four-month period following the date of this order, the stay shall remain in effect until the criminal case is resolved through entry of a plea of guilty or no contest, conviction, or dismissal. If no criminal charges are filed within four months of the date of this order, the presiding officer will conduct a status conference with the parties and determine how to move this case forward.
