BY THE PRESIDING OFFICER:

On January 17, 2013, the above-named Respondents, by and through their counsel of record Paul T. Moxley, filed a motion to stay the administrative proceedings in this matter. Respondents urge the stay due to the possibility that criminal charges might be filed against them on allegations similar, or related, to those on which this administrative action has been brought. The Utah Division of Securities (Division) does not oppose the motion for stay. In these circumstances, the presiding officer finds that granting the motion for stay is warranted.

Subsequent to the passage of time, the parties deem it desirable to continue the stay in this matter.

ORDER

The administrative proceedings in the above-captioned case numbers are stayed. If a criminal case is filed within four months of the date of this order, the stay may remain in effect until such time as Respondent enters a plea of guilty or no contest, or alternatively, the case is dismissed. In these circumstances, Respondent shall notify the Division within five (5) days of resolving the criminal case through plea or dismissal. If a criminal case is not filed within four months of the date of this order, this matter shall come under further review by the presiding officer.

This Order shall be effective on the signature date below up and through four (4) months therefrom.


