NOTICE OF HEARING

BY THE PRESIDING OFFICER:

The notice of agency action and order to show cause in this matter were sent by the Division of Securities (Division) to the above-named Respondents on January 28, 2013. On March 4, 2013, Respondent timely filed a response to the Division's allegations. A prehearing conference was held on March 6, 2013.

The presiding officer now enters the following scheduling order:

1. If Respondent wishes to amend or augment his March 4, 2013 response, he shall do so by March 20, 2013.


2. The parties shall comply with the initial disclosure requirement of Utah Administrative Code § R151-4-503 (available for review at <http://www.rules.utah.gov/publicat/code/r151/r151-04.htm#T30>) by March 20, 2013.
3. The parties shall complete discovery by April 26, 2013.
4. Should either party determine to use an expert witness, the party shall disclose the expert's name, contact information, and written report no later than April 26, 2013.
5. Any motion for summary judgment, judgment on the pleadings, or other dispositive motion shall be filed no later than May 3, 2013. If any such motion is filed, the presiding officer shall issue a supplemental notice setting deadlines for response and reply, and scheduling oral argument if requested or required. *See* Utah Administrative Code §§ R151-4-303(2) (available for review at <http://www.rules.utah.gov/publicat/code/r151/r151-04.htm#T22>) and R151-4-107(2) (available for review at <http://www.rules.utah.gov/publicat/code/r151/r151-04.htm#T7>).
6. Pursuant to Utah Administrative Code § R151-4-504(2) (available for review at <http://www.rules.utah.gov/publicat/code/r151/r151-04.htm#T31>), the parties shall exchange final disclosures by May 10, 2013.
7. Unless this matter is settled through a stipulated agreement, resolved through an order issued on a prehearing motion, or continued for good cause, a hearing shall take place before the Utah Securities Commission (Commission) on May 23, 2013.
8. Should Respondent's family schedule make it more convenient for him to appear for hearing in July of 2013, the hearing shall be continued at his request, provided that his request is received by the Division no later than May 9, 2013. Respondent is

hereby placed on notice that the Commission is currently scheduled to meet on July 25, 2013, with that date subject to change.
