**BY THE UTAH SECURITIES COMMISSION:**

On May 30, 2013, the Utah Securities Commission (Commission) heard oral argument on a motion by the Utah Division of Securities (Division) for a default order against Jared Brent Muir (Respondent); on a motion by the Division to strike a statement Respondent filed in opposition to the Division's motion for default; and on a motion by Respondent for leave to amend his answer. Having reviewed the filings and considered the parties' arguments, the Commission now enters the following order.

**ORDER**

Based on the admissible evidence submitted and arguments of counsel, the Commission believes that Respondent's failure to timely file an answer that complies with Utah Code Ann. § 63G-4-204(1) is due to mistake, inadvertence, or excusable neglect. Therefore, the Division's motion for default is denied.

For the reasons set forth in the Division's motion to strike Respondent's affidavit, the motion is granted.

Respondent's motion to amend his answer is granted. Respondent shall file a response that complies with Utah Code Ann. § 63G-4-204(1) within five business days of the date of this order.


