BY THE PRESIDING OFFICER:

On April 24, 2013, Respondents Michael J. Hansen and CEMAGROUP, LLC, by and through counsel Mark W. Pugsley and Maria E. Heckel, filed a motion to stay the administrative proceedings in cases SD-13-0022 and SD-13-0023. On April 29, 2013, Respondent Kenneth E. Day requested a stay of case SD-13-0021 as well. Respondents urge the stay in order to allow for related criminal cases to be resolved. Respondent Hansen was charged on April 18, 2013 in case number 131903769 (Third District Court, Salt Lake County, Utah) with two counts of second degree felony securities fraud and one count of second degree felony theft. Respondent Day was charged on April 18, 2013 in case number 131903770 (Third District Court, Salt Lake County,

Utah) with one count of second degree felony securities fraud and one count of second degree felony theft. The Division does not oppose a stay.

Given the foregoing, the presiding officer finds that granting the motion for stay is warranted.

ORDER

The administrative proceedings in Division case number SD-13-0021 are stayed until criminal case number 131903770 as herein specified has been resolved through entry of a plea of guilty or no contest, conviction, or dismissal. The administrative proceedings in Division case numbers SD-13-0022, and SD-13-0023 are stayed until criminal case number 131903769 as herein specified has been resolved through entry of a plea of guilty or no contest, conviction, or dismissal. Each Respondent shall notify the Division within ten (10) days of resolving his criminal case.

The initial hearing scheduled in these matters for May 1, 2013 is continued and will be rescheduled after the stay is lifted.
