**BY THE PRESIDING OFFICER:**

The notice of agency action and order to show cause in this matter were sent by the Division of Securities (Division) to the above-named Respondents on July 2, 2013. On July 31, 2013, Respondents timely filed an answer to the order to show cause. A prehearing conference was held on August 7, 2013.

The presiding officer now enters the following scheduling order:

1. The parties shall comply with the initial disclosure requirement of Utah Administrative Code § R151-4-503 by August 23, 2013.
2. The parties shall complete discovery by October 7, 2013.

3. Any motion for summary judgment, judgment on the pleadings, or other dispositive motion shall be filed no later than October 14, 2013. If any such motion is filed, presiding officer will issue a supplemental scheduling order establishing deadlines for response and reply and setting a date for oral argument, if required or requested.
4. Pursuant to Utah Administrative Code § R151-4-504(2), the parties shall exchange final disclosures by October 21, 2013.
5. Should either party determine to use an expert witness, the party shall disclose the expert's name, contact information, and written report no later than November 7, 2013.
6. Unless this matter is settled through a stipulated agreement, resolved through an order issued on a prehearing motion, or continued for good cause, a hearing shall take place before the Utah Securities Commission on December 5, 2013.
