**FINAL ORDER AND JUDGMENT AS

This case came before the Court on the motion to dismiss of Richard W. Mack, joined by Walnut Street Securities, Inc. and Carole A. Turner (collectively "the Moving Defendants"). On July 14, 2006, the Court signed an Order dismissing the Division's claims against the Moving Defendants pursuant to Rule 12(b)(6) of the Utah Rules of Civil Procedure for failure of the Complaint to state a claim for relief against the Moving Defendants. On August 25, 2006, Richard W. Mack moved the Court under Rule 54(b) of the Utah Rules of Civil Procedure to enter a final judgment as to Richard W. Mack. That motion is unopposed.

After considering the moving papers and related memoranda, the pleadings, relevant law, and arguments of counsel, it is hereby ordered, adjudged, and decreed as follows:

ORDER AND JUDGMENT

1. Richard W. Mack's Motion for Entry of Final Judgment based on the Court's Order dated July 14, 2006 is GRANTED.

2. The Court EXPRESSLY DETERMINES that there is no just reason for delay and EXPRESSLY DIRECTS the entry of this final judgment dismissing the case against Richard W. Mack on the merits and with prejudice pursuant to Rule 54(b) of the Utah Rules of Civil Procedure.


