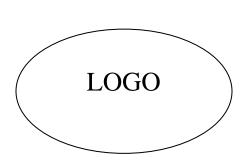

OTHER BUSINESS ACTIVITIES

In addition to being investment adviser representatives (hereafter "IA Reps") of Sample Advisor, LLC (hereafter "Sample Advisor"), both John A. Sample (herafter "Sample") and Jane Soandso (hereafter "Soandso") are licensed as independent insurance agents in Utah.

Both Sample and Soandso, as IA Reps of Sample Advisor, may make recommendations on insurance products and may also, as independent insurance agents, sell those recommended insurance products to advisory clients. When such recommendations or sales are made, a conflict of interest exists as Sample and Soandso may earn insurance commissions for the sale of those products, which may create an incentive to recommend such products. Sample Advisor requires that Sample and Soandso disclose this conflict of interest when such recommendations are made. Also, Sample Advisor requires Sample and Soandso to disclose that advisory clients may purchase recommended insurance products from other insurance agents not affiliated with Sample Advisor.

ADDITIONAL COMPENSATION

Aside from the sales commissions paid by insurance companies to Sample and Soandso (see the "OTHER BUSINESS ACTIVITIES" section above), neither Sample nor Soandso receive any additional compensation from non-clients for providing advisory services. All advisory compensation is paid by clients directly.

SUPERVISION

As president of Sample Advisors, John A. Sample is primarily responsible for supervision of Sample Advisor and its IA Reps. As Sample is an IA Rep himself, his accounts are also reviewed by the vice-president of Sample Advisors Jane Soandso. All financial plan recommendations are reviewed by both Sample and Soandso before the financial plan is complete. For portfolio management recommendations, Sample and Soandso review all recommended transactions at the end of each day. Both Sample and Soandso also review accounts as a whole each quarter in conjunction with the calculation of advisory fees. Advisory clients may contact either John A. Sample or Jane Soandso directly.
